 Nowadays, at the time of COVID-19, where social distancing is the norm and when assembling with higher number is a risk; Tsin'At becomes handy to keep the culture of kindness to each other alive; Tsin'At can timely and safely assist a saddened family.

Semi Annual (six month) Operational Report on Activities of Tsin'At

In accordance with the set purposes, goals and objectives of the association, the following are activities between January and June of 2020.

- 1. On 2/25/20 an annual Tsin'At, general assembly of members took place; on the meeting:
 - Report on operational activities and financial status were presented.
 - Discussions, questions and answers on different subject matters were entertained.
 - Members new registration and renewals were conducted.
- 2. Tsin'At board has been meeting regularly once a month using Zoom as a means. Board members are covering the annual cost as donations to the association; the total annual cost is \$300.
- 3. Tsin'At paid out benefits to the beneficiaries of the following two deceased members:
 - > Alganesh Tekie on 3/16/20; \$15,000
 - ➤ Hiwet Mender Mender on 5/28/20; \$15,000 for a total out flow of \$30,000. (please see below subsequent events for updates)

Tsin'At leadership representatives visited the two family's members; and participated in the second funeral process.

- 4. Membership drive as of June 30, 2020
 - Registered members, 388.
 - Registered members who didn't pay their due, **2**.
 - New members this year (2020), **42**.

The cut off for this Newsletter is June 30^{th} ; as a result, the above operational and fiscal report did not include important incidents that took place while we are in publication and below are the updates:

- Two dear members of Tsin'At passed: Mr. Habtezghi Weldai and Ms. Tsegeroman Haile passed in the month of July.

 Tsin'At extended its condolences to the family and fulfilled its obligation by remitting \$30,000 to the beneficiaries.
- ➤ As a result of those four continuous incidents, reserve fund balance failed below \$30,000. Consequently, Tsin'At board on July 23, 2020, based on the bylaws of the association assessed 50% of annual dues per type of membership to be paid by August 31, 2020.

Reminders from the bylaws:

Section 3.00 Membership

- H. A dependent of a registered member who reaches age of 23 must file a new application within 90 days of his/her birthdate with the Board. This is considered change in membership status and section "3.01.H" will apply. However:
- 1. Membership benefits shall remain in effect without any interruption or waiting period for the 90 days.
- 2. If a dependent fail to file a new application within 90 days of his/her birthdate in file, his/her membership automatically will be considered a voluntary cancellation. If the person elects to establish membership at a later date, he/she can do so by registering as a new member.

Section 4.02 The Authorities and Duties of GB

- H. The GB is responsible to monitor the financial status of the association. Consequently, the GB:
 - 1. Reviews and approves revenue and expenditure budgets as prepared by the Finance Committee (FC)
 - 2. Reviews at a minimum, quarterly financial reports that include details of revenues and expenditures prepared by the Treasurer and FC and reviewed by the IAs.
 - 3. Has the authority to:
 - i assess additional fees of up to \$100 per member if reserve fund balance fails **below \$30,000** per FC report.
 - ii call an emergency meeting of GA if the association is faced with a challenge beyond its capacity or cannot meet the financial obligations per FC assessment.
